The Company has identified an inadvertent error and accordingly, please find below the updated clarification.

In the said article, it was mentioned that India has cancelled grid access for nearly 17 GW of delayed clean energy projects to prioritise connections for those that are operational or nearing competition, and that the CTUIL has informed companies including Adani green, ReNew power, NTPC, Avaada Group, JSW Energy and ACME Solar, about such cancellations.

It is clarified that no revocation of any of the connectivity of projects of ACME Solar Holdings Ltd is in effect as of today, and we have not received information in respect to any such revocation/cancellation from CTUIL which is currently in force.

Further, we would like to state and confirm that the Company is compliant with the provisions of Regulation 30 of the Listing Regulations and has been regularly submitting necessary disclosures with the Stock Exchanges, as required thereunder, from time to time. The Company shall
